Dear Sir/Madam,

Kindly refer to the subject cited above it is to inform you that as per the instructions issued by the Government of HP, Department of Elementary Education has allowed of intake of Diploma in Elementary Education seats to the Govt. DIETs & Privately Managed Institutions for the 2 years D.EI.Ed. for the batch/session 2025-2027 as per the list of institutions. Out of an approved intake of D.EI.Ed. seats to the privately managed institutions, 50% seats are Subsidized and 50% seats are Nonsubsidized, for which candidates shall be sponsored for 2 years D.EI.Ed. Batch/session 2025-2027 to your institution as per the reservation roster and fee structure approved for the purpose. Total of 12 Govt. DIET's and 28 privately managed institutions recognized/approved intake capacity by the NCTE for aforesaid course. Whereas, 17 affiliated institutions (out of 28) affiliated with this Board at for the batch/session 2025-2027. Detail is as under: -

I would also like to inform you that to select candidates for allotment to your institution as per approved intake capacity, the Board is holding counselling at its headquarter at Dharamshala at 10 AM onwards on each day w.e.f. 04-08-2025 to 14-08-2025. We have directed the candidates to come for the counselling along with a cash of Rs.9900/- as an advance tuition fee, if they wish to opt your Institute, which will be deposited with your institution in the event of his/her selection on the spot immediately after the counselling to ensure his seat. However, other monthly/annual charges shall be deposited at the time of admission by the selected candidate in the institute itself. As far as the payment of balance tuition fee is concerned, the same shall be split in equal installments and shall be deposited with your institution during the 1st year of the training itself. A copy of fee structure as prescribed by the Department of Elementary Education to Government of Himachal Pradesh, will be provided to you at the time of counselling. However, there is no provision of advance fee for Govt DIET's.

The following conditions will be applicable for two years D.EL.Ed. Course batch/Session 2025-2027 as prescribed by the Govt. of Himachal Pradesh: -

- 1 90% Attendance would be necessary in the D.EL.Ed. training course.
- 2 45% will be the pass marks in D.EL.Ed. Examinations of the 1st year and 2nd year'
- 3 Merit and seniority will be on the basis of the marks secured in the D.EL.Ed. pass course.
- In case the trainees take leave on medical grounds/maternity purpose then the training may be extended by the duration of leave taken.
- 5 During the training the candidates would not pursue any other Educational course/study either regular or through distance mode.
- 6 The D.EL. ED Courses only an academic course. Passing of D.EL. ED course successfully does not confer any vested or accrue right to the candidates for appointment in Government job.

In view of the above, you are (as Head of Privately Managed Institute) requested to ensure your personal presence or depute your authorized representative along with your fee clerk with a proper 'Receipt Book and office seal to collect advance tuition fee@ Rs.9900/- from each sponsored candidate during the counseling at Board's Headquarters on prescribed dates. You are (as Head of Govt DIET or Pvt. Institute) also directed to ensure admission of the candidate as per allotment letter and to inform this office about status of their joining telephonically as well as in writing.
